In connection with the observation of Swachhta Action Plan this office proposes to undertake the **Construction of two new toilets and related works at Jeevan Gnanodaya High School for the Deaf, C-46, 5th Cross Street, Anna Nagar, Chengalpattu – 603 001 [run & manage by Jeevan Gnanodaya Charitable Trust (regd)].**

2. Interested parties possessing the infrastructure for completing the work mentioned in para no.3 may visit our Official Website "**settlementcommission-cest.gov.in**" and download the tender details and after inspecting the school premises (with the knowledge of the school authorities) can submit their quotations.

3. The quotes should include a detailed report with drawing for the proposed work. The quotations should also include all materials, labour and all transportation costs in connection with the proposed work. The details of the proposed work are given below and are expected to complete the said work within a time span of 1 month from the date of issue of work order.

WORK DETAILS

Toilet: 2 Nos.

Sl. No	Description
1	Providing and fixing of M.S metal roofing work of M.S all frame work 20X11' (1 no.).
2	Brick wall for passage (100 or 150 mm solid block wall for toilet construction).
3	Supply and fixing of tiles work of floor and wall.
4	Supply, fixing, installation, commissioning of white/vitreous china floor Indian type closet and internal fittings with accessories including cutting and making.
5	Painting work of applying for new toilet brick wall emulsion painting and M S frame of one coat redox and one coat enamel painting (manual painting).
6	PVC doors for toilets.

4. All the materials to be used should be made in India and of standard quality bearing ISI marks.

5. Interested parties should possess the following eligibility criteria.

(a) They should be registered with GST and should possess a PAN number and have a minimum of 2 years experience in similar nature of work; copies of GST Registration , PAN card and documents in support of work experience should be enclosed with the quotation.

(b) No advance will be paid for the work till completion. Final payment will be made only on submission of completion report from the school.

6.
